#### Preamble

- ❖ This Memorandum of Understanding (this "MOU") made on this 05<sup>th</sup> day of the March 2020, between Nehru Memorial College (Autonomous), Puthanampatti, Tiruchirapalli District, Tamil Nadu and Chidambaram Pillai College for Women, Mannachanallur, Tiruchirappalli, Tamil Nadu, collectively referred to as the "Institutions" or the "Parties",
- \* RECOGNIZING their mutual interest in research, development, and education on a non-commercial basis, and also
- ❖ RECOGNIZING the global nature of today's business, industrial and social problems, and the need to address them through international cooperation,
- HEREBY agree to encourage collaboration according to the terms and conditions set forth in the following articles.

#### 1: Fields of Collaboration

❖ Nehru Memorial College (Autonomous) and Chidambaram Pillai College for Women, may collaborate within any mutually agreeable field of research, education and quality initiatives.

## 2: Exchange of Faculty and Research Scholars

- ❖ Nehru Memorial College (Autonomous) and Chidambaram Pillai College for Women will encourage collaboration in research, education and quality initiatives in areas of mutual interest, through reciprocal arrangements for faculty and research scholar exchanges.
- ❖ The administration of the two institutions agree to assist their respective faculty members in developing scholarly exchanges that may include a range of interactions such as research collaboration, specialized lectures, seminars, teaching or submission of joint research proposals and helping to obtain accreditation by NAAC.
- ❖ Both parties must agree upon the specific terms of any interinstitution initiative in relation to this agreement in writing or electronically recorded correspondence at least three months prior to the initiation of a particular program or activity in order for the said initiative to proceed.

\* The host institution, in the pre-visit agreement correspondence, will also coordinate support with the visiting institution for office space, library, laboratory and other privileges appropriate to the level and purpose of the visit, subject to the availability of resources.

## 3: Administration and General Provisions

This MoU shall have an initial duration of five years from the date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, in five-year increments, by mutual written agreement
