The sanction of the President is hereby conveyed for the organization of above mentioned INSPIRE Internship Science Camp for 150 students during 01-05 August, 2016 at Nehru Memorial College, Puthanampatti, Tiruchirappalli District-621007, Tamil Nadu at a total cost not exceeding Rs. 9,75,000/- (Rupees Nine Lakh and Seventy Five Thousand only).

2. The sanction of the President is also accorded to the payment of Rs. 8,00,000/- (Rupees Eight Lakh only) to the Principal, Nehru Memorial College, Puthanampatti, Tiruchirappalli District-621007, Tamil Nadu as the initial grant for organizing the above mentioned program and the final release will be made on receipt of Utilization Certificate and Statement of Expenditure from the host Institute.

3. It is certified that travel by Air/Rail/Road (Car/Taxi etc.) in this case is urgent and considered necessary in the public interest. The sanction of the President is also accorded to the performance of Journey by Air/Train (1st Class/AC2tier/AC3tier) /Road (Own Car/taxi etc.) by the participants as per their entitlement in their parent organization.

4. As per Rule 211 GFRs, the accounts of the Grantee Institution will be open to inspection by the sanctioning authority/audit whenever the institute is called upon to do so.

5. The grantee institute will furnish to DST, the utilization certificate and audited statement of accounts pertaining to the grant within Sixty days from the date of the event. Any unspent balance amount will also be refunded to DST soon after the event.



- Since the application is submitted online, a hard copy of application along with uploads including the Endorsement certificate from the Head of Institute, Program Schedule etc. and a copy of the sanction order needs to be submitted along with the declaration that the organized INSPIRE internship science camp was residential in nature.
- Student's attendance (signature only) for each day (5 Days)
- Student Feedback Summary by the Program coordinator
- Each Mentors Feedback and Course coordinators feedback
- Soft copy / Video-graphy of the five days program on external Hard Disk Only.
- List of students with cut off marks, address and signature (Scanned copy) of the students is required in soft as well as hard copy.
- List of Mentors along with the scheduled as followed by the organizers along with the title of the talks/interaction carried each day by the mentors.
- Practical session details in the form of hard copy as well as soft copy.
- Scientific and technical write-ups of 1st, 2nd and 3rd award winners needs to be submitted in hard as well as soft copy.
- Utilization Certificate and Statement of Expenditure (2 Copies) needs to be submitted in DST format only.
- DD of Unspent balance if any in favor of Drawing and Disbursing Officer (DDO), DST payable at New Delhi


Complete report should be submitted one go and it will not be considered in bits and pieces.
