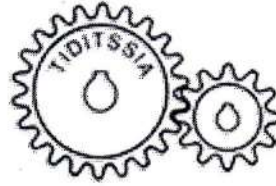

This Memorandum of Understanding is entered into at Puthanampatti, Tiruchirappalli District, Tamilnadu, India on 17th of September, 2018 (hereafter called MoU)

through Department of Chemistry (Government Aided College affiliated to Bharathidasan University, Tiruchirappalli and recognized by the University grant Commission, New Delhi under section 2 (f) and 12 (B) of UGC Act 1956) represented by **Dr. A. R. PonPeriasamy**, Principal of the college aged about 56 years, hereinafter called the First Party, which term and expression shall mean and include, unless repugnant to the context, its successors, assignees, administrators of the **First Part**.

And

The Tiruchirappalli District Tiny & Small Scale Industries Association, Tiruchirappalli represented by its **Mr. S.Punniyamoorthy, B.E.**, Secretary / TIDITSSIA

which expression shall mean and include, unless repugnant to the context, its successors, assignees, administrators of **the Second Part**.

All the Parties Department of Chemistry, Nehru Memorial College and The Tiruchirappalli District Tiny & Small Scale Industries Association, Tiruchirappalli, are collectively referred to as “The Parties “

1. Objectives

Nehru Memorial College and TIDITSSIA, recognizing their mutual strengths and interests to develop personality, to educate and agree to share their information, experience, infrastructure facilities, organization of national and international seminars, conferences, workshops, symposia, job oriented short term and long term courses, computer training, faculty improvement programmes, exchange of faculties for various academic and research programmes and different consultancy, funded and sponsored projects, exchange of library facilities, use of equipments and machinery facilities, Training, Industrial visits & Curriculum oriented projects for **Nehru Memorial College (Autonomous), Puthanampatti** students and faculty and other stakeholders, therefore agree to collaborate. It is understood that the content and process of TIDITSSIA is secular and non cult based. The TIDITSSIA to conduct Certificate and other courses for the community of Nehru Memorial College and its stake holders will be in the form of skill development and wellness programme.

The activities under this collaboration shall include:

Promotion of Women Entrepreneur is taken as special area of Cooperation. The “Entrepreneur Development Cell” of Nehru Memorial College (Autonomous), for women expects to conduct skill based training programmes to the students and agrees to permit their women experts in its concern to share their expertise with the students and faculty members.

TIDITSSIA also agrees to help students of Nehru Memorial College (Autonomous), Puthanampatti by **Conducting Campus Recruitment at NMC** and provide internship in its members Industries / concerns subject to availability of vacancies and norms of TIDITSSIA

Any other programmes in future that both the parties find it mutually beneficial can be included in the MOU by making necessary amendments with the consent of both the parties

2. Duration

This MoU shall remain in force for a period of One year commencing from the date of signing and may be reviewed by mutual consent by serving 3 months written notice to the other party. Upon renewal, both parties shall select either to proceed with the existing or new terms of understanding.

3. Amendments

Any of the provisions of this agreement may be amended or modified at any time by mutual consent through exchange of letters, and all such amendments shall be part and parcel of this agreement.

4. Dispute Resolution

Should there be a dispute relating to any aspect of the cooperation, the Secretary TIDITSSIA and the Principal, Nehru Memorial College will jointly resolve the dispute in a spirit of mutual respect, independence and shared responsibility. Any notice required to be given under this agreement shall be served on the party at their respective addresses given below by hand delivery or by registered post.
