The Meeting of the Academic Council was convened at 10.00 a.m. on 10 April, 2019 in the Seminar Hall, IT Block.

The Principal and Chairperson of the Academic Council Dr.A.R.PonPeriyasamy welcomed the members of the Academic Council. He also introduced the new members to the council and requested the members present to offer their valuable suggestions for the betterment of the academic pursuits and the steady growth of the college. Then the Chairperson permitted the Member Secretary of the Academic Council Dr.K.T.Tamilmani to take up of the agenda of the meeting one by one for consideration.

Dr.K.T.Tamilmani presented the first item of the agenda. He highlighted the amendments made in the regulations for UG/PG be adopted from the academic year 2019-20 and sought for its approval. Then Dr.M.Muralidharan presented the MCA regulations to be implemented from 2019-20 and sought for its approval.

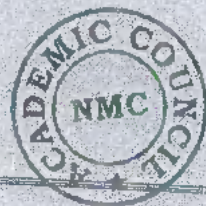

Then the Chairperson of UG Board of B.Com Computer Applications Ms.A.Jannathul Firdhoes presented the Course Structure and detailed syllabi of B.Com CA and sought for approval of it from the council. After detailed discussion, the members of the council passed the following resolution.

Resolution No.AC 45/ 2019

It is resolved unanimously to approve of the course structure, syllabi and scheme of study for B.Com (Computer Applications) programme to be implemented from the academic year 2019-2020. The Course Structure and the detailed syllabi of B.Com (Computer Applications) programme is enclosed separately.

Then the Chairperson of UG Board of Business Administration Mr.M.Kirubakaran presented the Course Structure and detailed syllabi of B.B.A. and sought for approval of it from the council. After detailed discussion, the members of the council passed the following resolution.



Resolution No.AC 46/ 2019

It is resolved unanimously to approve of the course structure, syllabi and scheme of study for B.B.A. (Business Administration) programme to be implemented from the academic year 2019-2020. The Course Structure of B.B.A. (Business Administration) programme is enclosed as **ANNEXURE - 15** and the detailed syllabi of the programme is enclosed separately.

Then the Chairperson of PG Board of Business Administration Dr.M.Mary Anbumathi presented the Course Structure and detailed syllabi of M.B.A. and sought for approval of it from the council. After detailed discussion, the members of the council passed the following resolution.

Resolution No.AC 47/ 2019

It is resolved unanimously to approve of the course structure, syllabi and scheme of study for M.B.A. (Business Administration) programme to be implemented from the academic year 2019-2020. The Course Structure and the detailed syllabi of M.B.A. (Business Administration) programme is enclosed separately.

During the course of the deliberations, both internal and external members put forward a lot of suggestions and those suggestions were meticulously recorded and the responses/follow up actions/resolutions passed/ offered by the chairpersons/members were also mentioned below:

1. Dr.A.Edward William Benjamin suggested that the duration in which the students may complete the UG/PG programmes should be clearly spelt out in the regulations itself.



Resolution No.AC 48/ 2019

"It is resolved that the students of UG and PG programmes shall have 3 years of extension time to complete their degree programme and after the expiry of the prescribed period of study and they have to redo the programme."

2. Dr.P.Shanmugavadiyu suggested that the weightage for CIA Test I and Test II should be equal.

Resolution No.AC 49/ 2019

"It is resolved that the Mid Semester and End Semester Examinations shall be rechristened as CIA Test 1 and CIA Test 2 and both the tests shall have the equal share of the syllabi."

3. Dr D.Prabaharan observed that it is mandatory to provide a list of skill based and value based courses offered and students can opt for it from the list and the members also opined that the core courses also shall have more options for the students to select the course of their choice. And it is also suggested that every year new courses could be added in the list.

Resolution No.AC 50/ 2019

"It is resolved that the provision of choice based selection of core/skill based/value based courses should be considered by the respective Board of Studies in the future revision"

4. Dr.A.Edward William Benjamin suggested that the components of the CIA could be Seminar/ Assignment-cum-Seminar instead of Seminar/Assignment.

Resolution No.AC 51/ 2019

"It is resolved to amend the component of CIA as follows: Instead of Seminar/Assignment it may be mentioned as Seminar/Assignment cum Seminar". Further it is resolved that online test, quiz and other components may also be introduced.

5. Dr D.Prabaharan suggested that the nomenclature of professional courses in the MCA regulations may be changed as core courses to have uniformity in all the programmes



Resolution No.AC 52/ 2019

"It is resolved to rechristen the nomenclature of "Professional Courses" in the MCA degree programme as "Core Courses."

6. Dr.P.Shanmugavadivu suggested the provision of online courses in the MCA courses are appreciable in the context of eLearning and they should be relevant to the courses of study.

Resolution No.AC 53/ 2019

"It is resolved to offer the online courses in tune with the courses of study and a list of courses available in the NPTEL/SWAYAM/Coursera etc shall be notified to the students in advance"

7. Dr.P.Shanmugavadivu suggested that the college could establish an Innovation Centre for promoting research culture on the campus.

Resolution No.AC 54/ 2019

"It is resolved to recommend to the Governing Body to consider the establishment of Innovation Center to create a research ambience and to nurture and develop innovative research ideas which would eventually help the society at large."

8. Dr.P. Shanmugavadivu also suggested that research supervisor could focus more on interdisciplinary research.

Resolution No.AC 55/ 2019

"It is resolved that the Research and Development Cell may create an awareness among the faculty members to do research in the interdisciplinary area/field."

9. Mr.A.K.B.NawasBabu put forward the idea of Faculty Members to undergo a short training (3 days to 5 days) in the Industry so as to gain a first-hand exposure of the needs of the society and have a clarity on the graduate attributes to be focused.

Resolution No.AC 56/ 2019

"It is resolved to send the faculty members to undergo a short training or refresher programme to the relevant industries so that they can have a first hand



exposure/information about what do the industries expect from the graduates and how the institution could comply with their expectations."

10. Dr.A.Edward William Benjamin suggested that the college administration could come forward to offer seed money to carry to out minor projects initially on the campus and outside. For which Dr K.T.Tamilmani responded that the college has been doing this offering of seed money for research. Dr.R.Thirumurugan suggested that this offering of seed money could be extended to PG and M.Phil scholars too.

Resolution No AC 57/ 2019

"It is resolved to recommend to the Governing Body to provide a token amount of seed money to the faculty members with a duration of 2/4/6 months in a cyclic manner and encourage them to take up a project on societal needs. Further the scheme may be extended to PG,M.Phil and Ph.D Scholars too."

11. Dr. A. Edward William Benjamin suggested that timely completion of M.Phil and Ph.D. guidance by research supervisors should be recognized and honoured appropriately.

Resolution No.AC 58/ 2019

"It is resolved that the Principal may devise a suitable mechanism to find out the timely completion of guidance of M.Phil and Ph.D Students by the Research Advisors and he should also devise a suitable rewarding procedure in consultation with Research and Development Cell in order to encourage the research supervisors who do their duty in conscientious manner."

12. Dr.R.Thirumurugan suggested that there should be practical session in every semester of Science programmes in order to ensure the very purpose of introducing semester pattern from non-semester pattern.

Resolution No.AC 59/ 2019

"It is resolved that the provision of practical examination at the end of each semester shall be considered by the respective Board of Studies in the future revision"

13. Dr.J.A.ArulChellakumar suggested that the recent guidelines issued by TNSCHE could be taken up as the model for the pattern of the PG question paper.



Resolution No.AC 60/ 2019

"It is resolved that the following question paper pattern for PG students thus: Section A -- $10 \times 2 = 20$ Marks, Section B -- $5 \times 5 = 25$ (with internal choice) and Section C -- $3 \times 10 = 30$ Marks (3 questions out of 5 questions)."

14. The members discussed in detail about feed back mechanism and finally offered the following suggestions for improvement.

- *Modify the feedback analysis into Student's Satisfaction Survey*
- *Select any one least marked aspect from the feed back analysis every year and try to improve upon it*
- *Prepare a questionnaire and collect the information about career ambition/progression of students during the admission time and during the completion of the programme of study.*
- *Rearrange/Restructure the questions in students feedback according to SSS*
- *Relate Graduate Attributes with Students feedback questions*

15. The Members deliberated in detail on the syllabi of various programmes and suggested the following corrections to be incorporated in the respective syllabi.

B.Sc Mathematics:

- *Recommended to give "Basic Maths" course as a add on/certificate Course for all the students.*
- *"Discrete mathematics" in Elective Course must be moved to Core Course*
- *"Programming In C" in Core Course should be a elective course*

M.Phil. Mathematicss:

"Scientific Writing" could be introduced in I unit

B.Sc Physics:

Introduce IOT as elective instead of "C" course

M.Sc Chemistry:

"Green Industrial Chemistry" has to be renamed as "Green Chemistry."

M.Sc Computer Science:

"Ruby on Rails" in elective course may be added into "Open Source Technologies"

B.Sc Data Science:

- *Statistics-I & Statistics-II must be changed into Probability and Statistics-I and Probability and Statistics-II*
- *Digital Marketing must be added as one of the courses.*
- *Python and R is enough for Data Science. Java is not relevant*
- *Add tools currently used in Industry.*
- *Offer Data science certificate courses*
- *Analyse and research on the usefulness of the course after the 1st Batch of students completed their programme.*

M.Sc Data Science:

- *Linear algebra and Set theory must be introduced as a separate course*
- *Deep Learning must come under Core Course*
- *Define the period for Tri-Semester. For Tri Semester pattern regulations should be prepared.*
- *Data analytics in Humanities, Social Science, Socio-Economic studies, MIS etc must also be included in the syllabus*

M.Sc & M.Phil Botany:

Atleast Minimum content has to be revised

B.Sc Zoology:

EVS must not be removed. Modify the contents in Core Course.

BA & MA Tamil:

Tamil Computing & Internet usage may be added as one of the courses.

MA English:

Internship must be included

MBA:

Elective Courses must be properly structured

16. The members further offered the following suggestions for the improvement of the curriculum.

- *M.Phil: "Research Methodology" Course should be divided into 2 parts. First 3 units include common research methodology topics. Remaining 2 units should cover research areas relevant to the major.*
- *For all the courses: if there are 5 units in the course, minimum 5 objectives and 5 outcomes must be specified*
- *Staff may attend the online ARPIT course offered by MHRD.*



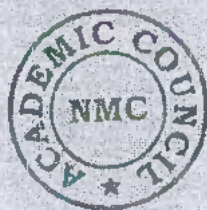
17. Dr.P.Neelamarayanan, Controller of Examinations requested the Chairperson of all the PG programmes to prepare a Question Bank (Multiple Choice Questions) for all the core courses and submit the same to the Office of the CoE in time. The Chairperson of all the PG Boards agreed to do so.

18. Dr.K.T.Tamilmani requested the Chairperson of all the UG Boards to adhere to the regulations given by Bharathidasan University with regard to the Part IV courses. The evaluation component of the Part IV courses should follow the pattern thus: Internal = 25 Marks and Semester Examination = 75 Marks (at par with the University). All the Chairpersons agreed to do so.

Under any other item Dr.A.Rajendran presented the need for making some special provision for the deserving NCC/NSS/Sports men & women students to take up more than that of the prescribed two courses in the instant examination on the basis of their meritorious achievements in NCC/NSS/Sports.

Resolution No.AC 61/ 2019

It is resolved unanimously to make special provision for the deserving NCC/NSS/Sports men & women students to take up more than that of the prescribed two courses in the instant examinations with effect from 2019-20 examinations.
